JVs \rightarrow \$36,000 est. (2016-17, \$40k)

LS 123 \rightarrow \$55,800 act. (2016-17, \$46k)

Moorefield Wind Project

Commercial Operation (May 2017)

Generated 558.8 MWh in 2017 (April-Dec)

472.4 MWh in 2018 (Jan-July)

Approx. \$26,000 returns to date.






LIFE IN 2017-18

- Paid in full loan from WWCFDC
- Distributed \$2600 through Community Fund
- Redeemed all LIFE bonds for shares/cash
- Completion of 25% purchase of MW1 debt (\$310,000)
- Successful completion & renewal of MW1 Bird/ Bat monitoring studies
- New member database
- Reduced rent to c. \$60/mth (base + meetings)
- Received EPP grant \$20,387




Net Income

Declaration of Dividends

 LIFE's Board has met and determined to issue the following dividends:

A.1 Shares: 4.5% dividend

– A.2 Shares: 3%

– A.3 Shares: 0%

Total distribution = \$11,923.50
 (Based on Net earnings of \$13,057)



3.b Resolution regarding A.3 Shares

 "All A.2 and A.3 shares shall be treated equally with respect to dividend payments made after the end of the year ending November 30, 2018."



3.c LIFE's Community Fund

- 10% of value of Dividends issued
 - = \$1192.35 for 2018
 - = \$3425.35 available for distribution
